- Current payslip
- Pension entitlements

- Any other income

- Living expenses (food, entertainment, clothing, transport, education, health insurance, medical fees)
- Personal expenses (sports, hobbies, subscriptions, other insurances, additional super contributions)
- Credit card debt
- Any other expenses or liabilities

- Vacant land
- House contents, collectables, jewellery
- Motor vehicles, boats, caravans
- Bank accounts
- Investments
